UPDATE ON N. IL. GROUP	Gary Clark said that CMAP had a meeting January 27, 2009. CMAP staff is responsible for writing a report (just like the MAC). Interesting comments: two of the committee members (one from industry & one from community) made it very clear that their groups are reviewing these chapters but they do not have any detailed comments at this time. These chapters are very preliminary. The chapters were background information on water planning & a little bit of water law. CMAP staff is very interested in looking at regional solutions & have reported before being very interested in water conservation measures. Big topic of discussion was Gary Clarks staff presented a paper that was prepared on Lake Michigan water allocation. Order is now official 200 communities

Allocation was set out for eight million people. Derek Winstanley said that in the official allocation to 2030 that they have made for all those communities, if you look at the quantity of water diverted and used from the diversion of 2030 it's the same as the water demand to 2030 in the MRI scenario. The best data available at the moment does suggest strongly that there is sufficient water to meet all the demands even at the high demand level within the region and this water to provide addition amounts of water.
