MOTION	MOTION BY BILL SMITH, SECOND BY BRAD UKEN to approve the June 27, 2008 meeting minutes.

MAC TREASURE REPORT	Dorland Smith went over the MAC treasure report. Please refer to packet.
STATE OF IL. BUDGET CUTS	Dorland informed committee that money had been pulled for the 3 rd year of RWSPC. MAC board discussed at the last meeting a couple weeks ago that if funding isn't there anymore where is the committee with this project. The funds will be there to finish the report. Unfortunately, No funding will be available for community outreach and education. The committee has approx. \$79,000 left to spend on copies & whatever else. Committee needs to keep in mind though that the full \$79,000 won't be spent on the full report because of other small expenses like lunches and what not. Jay Henry suggested to listen to the water surveys and where they are in the process. Gary Clark said that the money for the 3 rd year is gone. Money is very tight right now and in the next couple of weeks things will be changing drastically. As of now mid. August will be the drop dead date.
	Al Wehrmann said that there has been a lot of work on developing models and surface water analysis for the reservoirs and the

mackinaw river, that will probably stop. Vern Knapp said they have completed a model for the Sagamon river water shed which is a good thing. On the groundwater side a lot of drilling had been done. They have started inputting model layers into the flow model based on information from the geological survey. Also, they will be working on the model in the next couple months which will be an on going project. Things left undone will be the surface water analysis and a lot of field work that was planned which will not be done now due to additional field work being stopped. Which really hurts because the model is only as good as the data used to make it, so what happens without that additional geologic understanding means more uncertainty. A greatly reduced staff and no additional field work for the MAC area talking probably another \$150,000 dollars for the east central portion.

Jay Henry asked Al if they could button something up just to get to the committee and say here is the best we can do with what we got. Al said they cold try to do that. Jay said how useful would it be to the committee. Al said it would be very useful but his biggest problem with that is once people understand they have money till say the end of September they may not be there till the end of September. Gary Clark said there is no money till the end of September. Public spoke on behalf of the geological survey and that most of their efforts is state funded but really have an interwoven program with contract and state funding and pulling this apart has got them scrambling.

Dwain Berggren said that there is the appearance that something is vital and state welfare and next several generations are being thrown over the side. Dwain said he is reluctant personally to recommend expedience of any sort that excuse state leadership from fulfilling long-standing commitments and assuming the responsibility. I'm perfectly willing to shift whatever funds in our account that are mobile enough to do it to shift them to departments that are affected.

Bill Smith said that he has received a couple e-mails related to Derek Winstanley's role in this. Derek has since retired. Bill also said where is the chain of command. Al Wehrmann said he has an acting director Brian Anderson who is also the director of the Illinois Natural History Survey. Don Kiefers acting director is Don McKay who was the assistant chief prior to Bill Shilts is executive director of the institute for Natural Resource Sustainability who is at the top of ladder.

Al Wehrmann introduced Bob Martin, vice chair with Northeastern Illinois said the he has been talking to the U of I trying to make an impress that this is a very important project not only for East Central Illinois but Northeastern Illinois. Basically, trying to find out if there is anything that can be done at the university leave and needs to happen fast. Bob Martin said he has started out with the chancellors office went to the vice chancellor of research and now talking with the Institute of Natural Resource of Sustainability what they are trying to do is set up a meeting with individuals from the government relations group to decide how to best proceed and what he is trying to do and working with the MAC board also is to set up a meeting where we can sustain the people who are working with both the projects till we get pass this veto session. Right now he is trying to set up meetings with house and senate leaders with the governs office but that is out in the future because our media problem is what we going to do on the interterm. Trying to set up and have the university to see if they can fund this for right now to keep those projects going and that's what they are doing right now.

Chairman O'Neill said he got a phone call from Bob on Tuesday and he wanted RWSPC to be involved. So Chairman O'Neill will be sending a letter of support if they cannot make the meetings. Either one or both of them will be sitting in on the meetings to show support for the RWSPC. Brad Uken asked if they felt they are being passed down the chain. Bob Martin said No, he feels as though they are trying to get him to the right person. Brad Uken said how high do you feel you will have to go? Al said that they are not ruling anything or anyone out right now.
