Why is Illinois cooler in recent 30 period? This is related to sea surface cooling and heating.

When you push back data to the 16800 increases in precipitation are due to greenhouse effect then why in the 19<sup>th</sup> century?

Worst case drought in Illinois could be 5-10 year drought. Look at tree ring record to determine climate. The worst case drought using that method was 10 year drought.

Does it depend on drought as to the time if year and the high use and low use of consumption.

When drought occurs it is usually part of a regional drought.

Recommended reading is the Water Cycle and Water Budgets in Illinois: A Framework for Drought and Water-Supply Planning. This is on the ISWS website. Climate change on WHPA will be look out in sensitivity data.
